GLENN HEGAR

Elected in November 2014, Texas Comptroller Glenn Hegar serves as Texas' treasurer, check writer, tax collector, procurement officer and revenue estimator. Hegar is a sixth-generation Texan, who grew up farming land that has been in his family since the mid-1800s. Before becoming Comptroller, Hegar served in the Texas House of Representatives and the Texas Senate, and also served as chair of the Sunset Advisory Commission, which works to eliminate inefficiency in government agencies. Hegar attended Texas A&M as an undergraduate, where he earned a Bachelor of Arts. He then attended St. Mary's University, earning a Master of Arts and his law degree. At the University of Arkansas, he earned a Master of Laws degree. Glenn and his wife Para have three young children — Julia, Jonah and Claire.

DR. JIM HENSON

Or. James Henson directs the Texas Politics Project and teaches in the Pepartment of Government at the University of Texas at Austin. Since 2008, he has co-directed the University of Texas/Texas Tribune Poll, and has designed and implemented polls and provided strategic analyses for a wide range of non-profits and interest groups. He is a frequent contributor to The Texas Tribune and their companion site TribTalk, and his analyses of Texas politics appear regularly in media including The New York Times, the Los Angeles Times, The Wall Street Journal, The Guardian and other outlets. He is the principal author of a web-based textbook on Texas government, now in its third edition, that is used by thousands of students both at UT and at colleges and universities across Texas.




